Install vertically with cartridges
hanging down.

Allow 2½" (6.35 cm) clearance below the
cartridge for easy cartridge replacement.

The water inlet must supply a minimum of
40-85 psi (2.7-5.8 bar), non-shock.

Delime equipment prior to application.

OPERATION TIPS

Replace the Everpure 4FC5-S
Pretreatment Carbon Filter, 4CC Post
Treatment Calcite Feeder, and 4CB5 Post
Carbon Filter Cartridges and the Pentair
GRO-75EN RO Membrane Cartridge every
12 months.

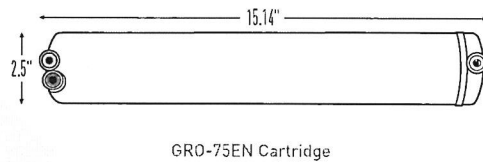
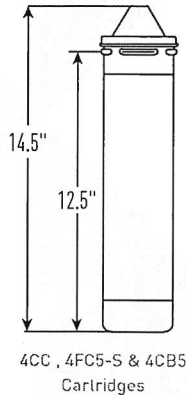
